**OPEN FORUM**

The Town will review the drainage plans for Greenfield Manor and have the Town engineer walk the property.

**CONSULTANT AUTHORIZATION**

Conrad Ziarniak, Chairman Zoning Board of Appeals, asked the Board to authorize a consultant to review all the materials that were presented to the Zoning Board of Appeals by Omnipoint for co-location on an existing cell tower on Drake Rd.

Some of the Board concerns were:

what percentage of the tower capacity will T- Mobile be using?

Are there other towers within a reasonable distance that have been considered?

(their propagation studies that were presented last night omitted everything west of the County line).

The ZBA wants to be sure that the tower space is used judiciously, and that a consultant would be able to advise on these types of issues.
