LIBRARY CHARTER

Lori Lessord, President of the Seymour Library Board and one of Clarkson's Representatives presented to the Town a copy of the Library Charter from the NYS Education Dept. Supervisor Kimball asked if the Town might be able to obtain a formal copy of the charter, so that it may be displayed in the Town Hall. She will follow up on that.

Lori also reported on the new program underway to promote the Library with local merchants. The program hopes to make customers/patrons more aware of businesses and library with promotions.
