**OUTDOOR FURNACE LAW**

Mr. Heckman reiterated that he would like to see the current law reviewed as he is 260 feet from his nearest neighbor and doesn't meet the current guidelines but feels alterations to the law could be made on case by case basis.

**BUILDING INSPECTOR POSITION**

Inspector position would then be on an as needed basis. Councilperson Filipowicz requested additional time to review the proposal. The matter was tabled until the May 13, 2008 meeting.
