Supervisor Kimball opened the meeting, and Sharon Mattison, Town Clerk led all those present in the Pledge of Allegiance. A moment of silence was observed for those serving in the military.

**OPEN FORUM**

Louis Sangiorgi of 457 East Avenue is interested in hooking to the sewer. Supt. Viscardi will contact Mr. Sangiorgi to perform a site inspection.

Tom Mayer of 8359 Ridge Road praised Supt. Viscardi for maintenance performed on the creek bed adjacent to his property. In addition, he voiced his concerns regarding a neighbor who keeps bee hives as well as chickens. C. Fabry responded that there is no Town ordinance against keeping bees and no NYS Ag & Market restrictions. Chickens are also allowed provided housing is 100 feet from the property line. Supervisor Kimball commented that the Board may want to consider whether or not to allow chickens within the Historical Overlay District.

**TOWN HALL STORAGE SHED**

The Board agreed to purchase a small shed to be placed in the south east corner of the back parking lot. The shed will be used for storage of tables and chairs which will allow for better accessibility. The cost will be approximately \$1,000.00.
