WHEREAS, the Town Board has before it a Map, Plan and Report for the proposed Clarkson Hamlin Town Line Water District in the Town of Clarkson; and

WHEREAS, that the Town Board has also received a Petition signed by the owners of properties in the proposed District; and

WHEREAS, this Board has determined that it is the Lead Agency; and

WHEREAS, this project is an Unlisted Action for the purposes of SEQRA; and

WHEREAS, the Project Engineer, Chatfield Engineers, P.C. has prepared a Short Environmental Assessment Form which has been signed by the Town Supervisor; and

WHEREAS, this Board having thoroughly reviewed the Environmental Assessment Form and considered each and every impact in accordance with SEQRA

NOW, upon consideration of the above and all of the previous documents, discussion and debate, upon the motion of Councilperson Hoy, seconded by Councilperson Filipowicz.

RESOLUTION ESTABLISHING WATER DISTRICT

In the Matter

The Creation of the Route 18 Clarkson Hamlin Town Line Water District, Town of Clarkson, Monroe County, New York

WHEREAS, a petition for the creation of the Route 18 Clarkson Hamlin Town Line Water in the Town of Clarkson, Monroe County, New York, said petition being dated November 6, 2017, was duly presented to this Board together with the necessary map and plan attached thereto; and

WHEREAS, an order was duly adopted by The Town Board on the 14th day of November, 2017, reciting the filing of said petition for the proposed district and the estimated expense thereof, and specifying December 12, 2017, at 6:00 P.M., as the time, and the Town Hall, 3710 Lake Road, Clarkson, New York, as the place, where the said Board would meet to consider the petition and to hear all persons interested in the subject thereof concerning the same; and

WHEREAS, such order was duly posted and published and served as required by law; and

WHEREAS, a hearing in the matter was duly held by the Town Board on the 12th day of December, 2017, commencing at 6:00 P.M., in the Town Hall, 3710 Lake Road in said Town, and considerable discussion upon the matter having been had and all persons desiring to be heard having been duly heard; and

WHEREAS, it is proposed that the cost of said district in an amount not to exceed \$378,752.75 to pay for the following improvements: seven thousand four hundred (7,400) feet of twelve inch PVC water main, seven valves, thirteen fire hydrants and all incidental equipment, including the necessary access to lands and the right-of-way therefore in accordance with plans prepared by Chatfield Engineers, P.C. and which were part of the petition filed on June 23, 2017; and

WHEREAS, the method for financing the balance of construction of the water district is by the issuance of Serial bonds in an amount not to exceed \$378,752.75 for a maturity not to exceed forty years in accordance with the provisions of the Local Finance Law of the State of New York; and

WHEREAS, the Town of Clarkson, by prior Resolution, has determined that this action will not have a significant impact on the environment and has issued a negative declaration for this project.

NOW, upon the evidence given at such hearing, upon the motion of Councilperson Didas, seconded by Councilperson Smith, it is

RESOLVED AND DETERMINED THAT:

- **A.** The petition aforesaid is signed and acknowledged or proved as required by law, in due compliance with the requirements of Section 191 of the Town Law as to sufficiency of signers with respect to the boundaries of the proposed extension as herein approved, and it is otherwise sufficient;
- **B.** All the property and property owners within the proposed extension are benefited thereby;
- **C.** All the property and property owners benefited are included within the limits of the proposed district; and
 - **D.** It is in the public interest to grant in whole the relief sought; and it is further

RESOLVED AND DETERMINED that the establishment of the district as proposed in said petition be approved; that the improvement therein mentioned be constructed upon the required funds being made available or provided for; and that such district shall be designated and known as the Route 18 Clarkson-Hamlin Town Line Water District of the Town of Clarkson, and shall be bounded and described as follows:

Beginning at a point, said point being the intersection of the centerline of Clarkson Parma Town Line Road and Roosevelt Highway Extension; thence

- C1. Southerly, 528 feet more or less, the centerline of Clarkson Parma Town Line Road, thence
- C2. Westerly, 8,150 feet more or less, along a line parallel to and 500 feet southerly of the centerline of Roosevelt Highway Extension and Roosevelt Highway (NYS Rt. 18) to a point, said point being on the easterly boundary of the Town of Clarkson Lawrence Road West Water District, also being the easterly property line of Tax Account No. 30.02-2-6; thence
- C3. Northerly, 83 feet more or less, along the easterly boundary of Town of Clarkson Lawrence Road West Water District to a point, said point being the northeast property corner of Tax Account No. 30.02-2-6; thence
- C4. Westerly, 278 feet more or less, along a northerly boundary of Town of Clarkson Lawrence Road West Water District to a point, said point being the southeast property corner of Tax Account No. 30.02-2-7; thence
- C5. Northerly, 444 feet more or less, along an easterly boundary of Town of Clarkson Lawrence Road West Water District also being the easterly property line of Tax Account No. 30.02-2-7 to a point, said point being the centerline of Roosevelt Highway (NYS Rt. 18); thence
- C6. Easterly, 8,433 feet more or less, along the centerline of Roosevelt Highway (NYS Rt. 18) and Roosevelt Highway Extension to a point, said point being the point of beginning.

All the lands and territory above described are situate within the Town of Clarkson and outside of any incorporated village or city; and it is further

RESOLVED that a Water District be established in said Town of Clarkson, Monroe County, New York, the description and boundaries of which shall be as above described; and it is further

RESOLVED that this district be established and combined with a district formed by the Town of Hamlin, Monroe County, New York, pursuant to a duly adopted Resolution of the Town Board of the Town of Hamlin, and that said districts, using an intermunicipal agreement, be managed as one joint district and that the total cost of said districts being of \$397,055.84 and indebtedness of said joint district be in the amount of \$397,055.84; and it is further

RESOLVED that the Town Clerk be and she hereby is authorized and directed to file a certified copy of this resolution, in duplicate, in the office of the State Department of Audit and Control, at Albany, New York; and it is further

RESOLVED that this project does not require the approval of the Office of the State Department of Audit and Control, at Albany, New York, because the projected annual cost of \$920.58 for a single-family residence is less than \$966.00 per year; and it is further

RESOLVED, that the Supervisor be, and he hereby is authorized and directed to make application to the Water Resources Commission of the State of New York for the approval of the Route 18 Clarkson Hamlin Town Line Water District; and it is further

RESOLVED, that this resolution shall take effect immediately.

TOWN CLERK REPORTS

S. Mattison reported on 2017 statistics, which included 170 lodge rentals and revenue of approximately \$10,000 for passport processing and photos. She commented about the possibility of an addition to the Justice Court to be used as the Town Hall in the future. She has been in touch with Senator Robach's office who will be investigating possible grants to help fund this proposed project.

BUILDING INSPECTOR REPORTS

C. Fabry has been busy doing fire inspections. Building projects have slowed down which is the norm for this time of year. Basset is ready to move forward with their second phase. The first phase is at approximately 60 to 70% capacity.

ASSESSOR REPORTS

L. Spencer reported that she is still very busy updating inventory.

HIGHWAY SUPT. REPORTS

R. Viscardi reported that final revenues for this year totaled \$289,561.71. A short discussion was held regarding the 2017 projects as well as possible projects for 2018. He reported on the age of current plow trucks, which include 2015, 2007, 2002, and 1999. He would like to replace the 1999 truck and suggests ordering a cab and rolling chassis, automatic, International, as has been done in the past. He purchased a body from Ogden for \$2,000 last year. The last truck cost \$225,000 and the one he is looking for is \$131,000. For another \$10,000 in incidentals we could have another truck. There is a 3% price increase after January 1st so he is hoping to place the order before then. The old truck would be sold at spring auction and hopefully sell for \$7,000 to \$8,000. We have \$80,000 in the budget for 2018. Two leases will be fulfilled in 2018 (Bobcat excavator and loader). We pay an upgrade fee every year on these leases.

R. Viscardi gave an update on the NYS Recycling Grant. We are slated to receive \$75,000, which could cover \$50,000 for a new used truck, \$25,000 for a new stationery compactor, two new packer boxes and an open top.
