Multi-family (3+)..... 0.20 sq. ft.....	\$75 min. fee
Manufactured homes (new or replaced).....	\$125

ACCESSORY STRUCTURES (includes C/C if req'd)

Town connection fee.....	\$250

NOTE: Fees include consultations with building inspector and inspections at the site. Permit fees may be doubled if no permit was obtained prior to the build. Cost based on square footage. Commercial permit fees listed DO NOT include certificate of occupancy or certificate of compliance fees if required.

PLANNING BOARD – Application Fees

Subdivision w/Site Plan

Note: For the purpose of development – site plan required

Residential (1 & 2 Family).....	\$300 plus \$25 per affected lot
Commercial.....	\$500 per lot
Telecommunications Tower.....	\$750 all zoning districts - plus ZBA Special Use Permit (\$150) & engineering deposit (\$1,000)

Resubdivision (all districts)

Note: For the purpose of lot line changes not involving development – instrument survey required

Lot line changes.....	\$150 per affected lot

Special Permit.....	\$150 (other PB fees may apply)
