Supervisor Report: Supervisor Filipowicz attended a zoom call with all other Monroe County Supervisors this past week. Discussion on the impact that COVID has on all towns and some more than others. Confusion and frustration is growing across the county. They discussed the Highway Municipal agreements that are taking place amongst neighboring towns and use of equipment. Rapid Testing is being offered for DPW workers and Police Departments with the hope that there is no threat to our service to the residents. Mapping by zip code is available online for those interested. Town and Village Court Closings will be a case by case decision for that area. Town and County Tax season is upon us and we are prepared if a COVID shutdown is needed. Info on Tax Exemption is available by calling the Assessors Office. The Clarkson Good Neighbor Newsletter has been distributed to the town through Westside News.

Town Clerk Report: Susan Henshaw discussed the Support Board members and who will be returning for 2021. Leslie Zink is the liaison for the board and is currently working on setting up the interviews for each individual board members that will be returning. Susan also advised that Clarkson will be reimbursed \$8,339.44 for our Election night expenses.

Councilperson Zink Report: Leslie Zink is on the Brockport CommUNITY Award selection Committee. The purpose of this award is to encourage, recognize, and reward individuals who have made exceptional contributions to enhancing and solidifying the fabric of the Greater Brockport Community. All residents of the Village of Brockport, the Towns of Clarkson, Hamlin and Sweden who have been actively engaged as leaders in building a sense of community in the greater Brockport community are eligible. This is the first year of the award, and the intent was to offer it at the opposite time of the year from the Monika Andrews Creative Leadership Award. However, there were numerous delays due to COVID. The plan is to virtually present this award at the Jan 4 Village of Brockport Board Meeting. The Committee is working on the nominations.

Highway Superintendent Report: Starting Saturday Dec 5 the highway night time snow watch began their winter hours 24/7. They had one event this week. The town has 500 tons of salt leftover from last year. We go through 2000 tons per year. The order was placed in July and it was the same price as last season. On Roosevelt Highway, they are finishing the waterline project with 2 more houses being completed and Burroughs Brothers Excavating will be finishing up soon.
