1-10-2023**Supervisors Report –**

Snowstorm – Thank you to all who came out to assist in any way during the late December snowstorm. The highway crew worked around the clock for five days. They plowed, took care of the pump stations, downed trees and power outages. Town board worked to prepare the Town Hall as a warming station. Kevin Moore worked with broken pipes at Wellington Woods. Our partners at the Town of Sweden-Kevin Johnson, the Village of Brockport–Margay Blackman and Brockport Central School Superintendent-Sean Bruno who opened the Oliver Middle School as a warming station to all in the community.

All Hands Monthly Meeting – Councilperson Culhane will host the next meeting tentatively held for Thursday, January 19.

Zoning Code – Councilperson Zink met with the Zoning Board last week and items discussed are moving forward and the next meeting will be in February.

He had a vet come in that would like to assist with others in his same situation. He would like to attend the next program date to offer guidance in any way.

Town Clerk Report - Susan wanted to introduce her new appointed Deputy Town Clerk, Stacey Yanklowski of Clarkson. Stacey has been a great asset to the Clerk’s office and she is acclimating very well. Town and County taxes are underway, not without a slight glitch to the delivery of the taxes. They were a few days delayed due to the snowstorm and the tax bills being mailed out of Buffalo. Otherwise it has been a nice start to the season.

Superintendent Report – Since the storm hit in December, the temperatures and warmer than normal weather have given the highway some pause so they may work on the drainage concerns along with the creeks and ash tree removal. The storm and high winds dropped many dead ash trees along the creeks and roadways. The highway employees have also been able to work on their PERMA Safety Training during this time.
