**WHEREAS**, the Town Board has before it proposed Introductory Local Law No. 5 of 2023 entitled **A LOCAL LAW TO ESTABLISH A TEMPORARY MORATORIUM ON CERTAIN LAND DEVELOPMENT APPLICATIONS THAT ARE PENDING OR MAY SUBSEQUENTLY BE FILED WITH THE TOWN OF CLARKSON;**
