CALL TO ORDER:

J. Jackson called the Planning Board meeting to order at 7:00PM and led the Pledge of Allegiance and read through the agenda for the night.

PUBLIC HEARING:

None were scheduled for this meeting.

OLD BUSINESS:

Applicant: John Lemke
Property Owner: John Lemke
Address: Ridge Rd west of 7165 Ridge Rd
Tax ID: 070-01-1-26.11
Acres: 13.9

Applicant requesting approval to subdivide the existing 13.9-acre parcel into eight building lots to be sold.

Dave Matt of Schultz Associates presented the plan with updates made since the previous meeting..

2 lots on Ridge R. will have a shared driveway.

Leech beds are placed where they are due to soil conditions and perk results.

Lot 4 changed to a three acre lot to meet the size requirements of flag lots in the Town.

The two ponds will be wholly owned by the two lots – 2 and 4. No ponds will straddle multiple lots.

Landscaping buffering added per J.P Schepp's request.

J/P Schepp went through his list of engineering comments from letter dated 9-19-24. Specifically, landscaping buffers, easement for drainage piping, etc. All have been properly addressed.

K. Moore asked for an easement on the pond for lot 4

The barn on the parcel has to be removed to meet code based on the plans submitted.

K O'Toole requested a driveway easement for a common driveway on lots 7 and 8.

K O'Toole requested a storm water maintenance agreement that will indicate the town has a drainage easement on lot 2 and 4. Dave Matt mentioned several lots including 2 and 4 have pond easements.

John Jackson motioned to declare this a SEQR type 1 action and acknowledges the receipt of the long form EAF which declares that the planning board become lead agency for the purpose of conducting a coordinated review and instructs the clerk notify the Involved Agencies of its intent to become Lead Agency along with a copy of the EAF for the Lemke Gallup Subdivision. Second by Dave Virgilio. Unanimously carried.

John Jackson made a motion for holding a public hearing for this application on November 19, 2024. Seconded by Daryl Fleisher. Unanimously carried.
