- **Minutes Portion in Red**
  - **Regarding 3723 Sweden Walker Road: L. Hale, searched documented records on this property, deed records found regarding the church 1827, church was reconstructed in late 1860's utilizing previous materials from another church.**
  - **A. Hoy comments on architecture of structure.**
  - **N. D'Amuro asks possible designation of structure.**
  - **A. Hoy comments that he thinks the building does not meet the criteria for designation**
  - **L.Hale asks about designation of the Palmer house as the church not being able to be torn down**

- Palmer house is in the original historic federal heritage area
- D. Maier requests on the owners intent and cites that the building code as visited in February of 2024 did not meet code, A. Hoy cites code issues
- Board comes to consensus to contact Kevin Moore building inspector to see what owner intent possibly could be and if interested in designation
- 7528/7538 West Ridge Road-investigation on use of building potential blacksmith shop and other uses as carriage house, cobblestone construction, during WWI rolled bandages for soldiers under the red cross.
- Board cites issue in documentation in the case of 7528/7538 need to contact Kevin Moore or other investigations
- 2892 Sweden Walker Road-Summerhays Home research during meeting may shed light on Ridge Road barn with conflicting address
